If said dues are not paid by November 1, 1965, those members not paid shall be subject to expulsion from the Club."
 - b) Article X - Dues Section 4 of the By-Laws be stricken and the following substituted in its place:

"4. Junior Membership shall include all persons seventeen (17) years of age to twenty-one (21) years of age whose parent or parents are active family members. All persons in this category are entitled to Junior Membership upon payment of dues. Article IX - Election of members does not apply to Junior Members."
 - c) Article X - Dues Section 1 be amended by striking therefrom the following: "five dollars (\$5.00) for each junior membership", striking the words "paragraphs 2 and 3" and substituting therefor "paragraphs 2, 3 and 4."
 - d) Article X - Dues Section 2 be amended by striking the words "eighteen years of age and older" and substituting therefor "twenty-one (21) years of age and older."
 - e) Article VII - Meetings Section 4, that the first sentence thereof, namely: "At any meeting each member 18 years of age or older shall be entitled to vote and shall have one vote," be stricken and the following two sentences substituted therefor:

"At any meeting each member twenty-one (21) years of age or older shall be entitled to vote and shall have one vote. The foregoing sentence shall become effective on the date of adoption by the Club and shall not affect any member's right to vote which accrued prior to adoption."
