Lodge Report

This year, more than any other, we need your EARLY attendance at a work weekend. The sooner we get people at the club helping to put rooms back together and in operation, the sooner we will be ready for the ski season, which is only 5-months away. In case you need reminding or are unaware of the work that needs to be done, let me restate our current position.

We had the front porch collapse in March. This made rooms 24, 1, 2, & 3 unsafe because the front of the building was pulled forwards. We have a contractor coming to reframe the front wall and rebuild the porch. The reframing will require exposing the internal walls of those rooms, along with the TV room and possibly the living room.

In addition to the rooms above, we also had obvious water damage (drips and leaks) along with damp in rooms in the derivative wing (16, 19, 20, 21), family wing (10, 11), and dining room. This means that there are parts of walls and ceilings missing in all these rooms, and the furniture and beds in these rooms were moved to other rooms while the original remediation was taking place. This means that more rooms are out of action because they are full of furniture. This may be a problem for some large groups or the Gran Fondo, depending on numbers.

Before we can start the easy work (painting, putting back furniture), we need to finish any demolition of the rooms to get back to solid places from which to start reconstruction. These rooms then need to be insulated and re-boarded. The clock is ticking, and we need everyone to step up and come to a work weekend sooner rather than later. If you are waiting until November, and we have not done all the rooms, it will be too late.

The following dates are on the calendar, but we can certainly add more if there is interest in more weekends with smaller groups.

JUNE 7-8: (Does anyone want to do another weekend in June?)
JULY 27-28: (Does anyone want to do another weekend in July?)
AUGUST: None planned. Anyone want a weekend in August? Note large groups 2-4 and 16-18.
SEPTEMBER 14-15: (Does anyone want to do another weekend in Sept?)
OCTOBER 5-6: (Does anyone want to do another weekend in Oct?)
NOVEMBER 2-3: (Does anyone want to do another weekend in Nov?)

I would like all members to let me know

The work weekend they will be attending,

or

That they will be paying the \$250 fee.

I am going to ask that you all decide which weekend you will attend or send in your money to Dan by July 1. If I do not get a date from you, I will assume you are paying and will ask Dan to send an invoice. We have to know who and when, because we have to plan.

If you can use a hammer and a saw, please plan to come sooner rather than later. If you can only paint, then come later, but we can't have 100 painters in November if there is no construction first.

Finally, I will remind all new members again that they must attend lodge meetings. There will be another one as we get progress updates from the contractor, to see how this process works. I would encourage the new families to attend one of the earlier weekends this year or even be bold enough to host a weekend. It's an easy task if the group is small, and older members will always help and give advice.

The building's future is an all our hands. Don't leave it for someone else to do the work, and don't feel like you have to only do one weekend.

Treasurer's Report

All invoices have been sent out to active members for FY2019. Only one inactive member has informed the E-Board that they would like to remain inactive. Current inactive members or members who would like to go inactive this year have until June 15 to let the president know of your decision.

We have received the check from Hanover in the amount of \$198,097.14. This does not include their fee, which we have sent to Petrocelli but has not been deposited. Because we have an outstanding loan balance with the Bank of New England for the furnace, they will need to co-sign the check before it can be deposited. Because our outstanding balance is only \$33,400, I was expecting this would not

take too long, but I spoke to a loan officer at the bank the other day, and they said they may want to come to the club for an inspection.

We have made the first payment to the contractor (MTR in North Woodstock) who will be making repairs to the club and replacing the roof. The payment was for all materials and a small amount of labor. If you are at the club over the next couple of months, you can expect to see them there.

Three members have made additional donations to the club's capital improvement account for a total of \$1,140. Thank you very much. Eleven member families have paid their dues for next year, and we have collected about 21% of the total invoiced amount.

This will be my last Yodeler input as treasurer. Although the job sometimes requires a lot of hours to document transactions and make filings, it really has been a rewarding experience. I would like to thank the many members who have helped me over the last three and a half years by answering my questions, providing feedback, and volunteering for the Finance Committee. I know that Kevin Baker will be getting the same support as the new treasurer.
